- 2. The shortlisted candidate should present his/her own research area before the committee for evaluation.
- 3. Based on the recommendations of the Selection Committee and approval of Board of Governors, the appointment letters shall be issued.
- IV. The candidate should pay a non-refundable application fees through SBI Collect as below: For Unreserved/EWS/OBC category: Rs. 1000.00 (Rupees One Thousand only). For Women, SC, ST & PwD category: Rs. 500.00 (Rupees Five Hundred only).

- 1. Applications received in the prescribed format only will be considered.
- 2. Fee once paid is non-refundable/non-adjustable.
- 3. Candidates applying for more than one post/department have to submit separate application form for each post along with requisite application fee..
- 4. For each of the qualifications, professional experiences, achievements, etc., documentary proof in the form of self-attested photo-copies to be attached with the application and original document to be produced, if called for interview.
- 5. The original documents must be produced at the time of joining for verification.
- 6. Incomplete application(s) without necessary enclosures shall not be accepted.
- 7. Copy of the category certificate (OBC/SC/ST/PwD/EWS), issued by the competent authority, not below the rank of a Tahsildar must be attached. In case of OBC candidates, the certificate indicating the status regarding creamy layer must be issued on or after 01.01.2021. PWD certificate must have been issued by the competent authority as per Government of India norms.
- 8. The eligibility, qualification, experience and requirements for the posts notified shall be governed by the guidelines issued by MoE (erstwhile MHRD) letter no. F.No.27-11/2011- TS.I, dated 23.04.2014.
- 9. The Institute reserves the right to fill or not to fill any of the vacancies advertised. The Institute reserves the right to reject any or all applications without assigning any reason.
- 10. Any misleading wrong information supplied by the candidates may lead to summarily rejection of the application, if found subsequently, also the appointment will be cancelled.

- 11. The Screening committee shall short-list the eligible candidates to be called for Test/Interview from amongst the applicants based on specialization and requirements of the departments.
- 12. Mere fulfillment of minimum qualification and experience requirements for the post does not entitle the candidate to be called for a written test/interview. However, applicants may send their advance copy of application but they have to produce NOC at the time of interview failing which they will not be allowed to appear in the interview. They have also to produce a certificate from the present employer that No vigilance case is pending/being contemplated against him/her.
