## **ELIGIBILITY**

- (i) Holding analogous post on regular basis in the parent cadre/ department **OR**
- (ii) with four (4) years regular service in posts in Pay Level-8 or its equivalent in parent cadre/department.

#### **General Conditions:**

- 1. Only Indian Nationals are eligible and need to apply.
- 2. Candidates should apply through proper channel only.
- 3. The last date for receipt of application: The last date of submission of application form, duly filled in all respect is 45 days from the date of publication of this advertisement in the Employment News. In the case of candidates residing in flanged/remote areas viz Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahaul and Spiti District and Pangi sub Division of Chamba District of Himachal Pradesh, Andaman & Nicobar Islands, Lakshdweep and for candidates residing abroad, the last date of submission of duly filled application form is 60 days from the date of publication of this advertisement in the Employment News. - 4. The last date is the cut-off date for all purposes including Age/Qualification/Experience etc.
- 5. NCPOR will have full discretion to fix separate minimum criteria for shortlisting and criteria for interview.
- 6. The prescribed essential qualifications are minimum and the mere possession of the same does not entitle candidates to be called for interview. If the number of applications received in response to advertisement is large, it will not be convenient or possible for the Selection Board to interview for all those candidates.
