The Institute is seeking applications from individuals for the following post to be filled on contract/deputation on Foreign Service basis on standard terms and conditions of the Government of India.

## **Prescribed Minimum Qualification / Experience:**

**Educational Qualifications:** M.E./M. Tech in Civil Engineering with 55% marks.

**Experience**: 8 years of experience as APE or an equivalent post in Govt/Autonomous bodies/PSU with a Grade Pay of Rs. 5400/-. However, those serving/served as Assistant Project Engineer on regular employment or on deputation at the institute for at least 8 years with M.E/M.Tech and exemplary service record can also apply [Age limit not applicable]. In case of contract appointment, those having at least 8 years of experience in relevant field as Senior level Engineer for infrastructure development/management in private sector such as corporates/private industries or reputed infrastructure firms or builders/institutions can also apply.

<u>Desirable</u>: Experience in development or operation or maintenance of a modern academic or corporate or similar infrastructure. Familiarity with modern practices in civil constructions and electrical power systems.

Deputation can be considered from the officers from the Central/ State Governments or Institute of national importance or Universities/ University level institution or PSU holding analogous post, and/or possessing educational qualification and experience as prescribed for direct recruitment.

## **Terms and conditions:**

- 1. The post of Deputy Project Engineer (Civil) is suitable for Physically Handicapped candidates with disabilities viz. Orthopedically Handicapped/Locomotor disability/Cerebral Palsy with One Leg Affected (Right or Left) (OL) and Hearing Impaired.
- 2. The candidate must be a citizen of India. Relaxation in age is applicable as per Govt. of India norms as applicable to the Institute. Maximum age (including all conditions) relaxation is up to 55 years for the post.
- 3. The post is on Deputation /contract basis for a period of 5 years.
- 4. Probation for contractual appointment is for a period of one year.
- 5. Candidates should apply through online mode only. Incomplete applications in any respect and application received physically shall not be considered.
- 6. Deputation can be considered from the officers from the Central/ State Governments or Institute of national importance or Universities/ University level institution or PSU
  - a. Holding analogous post, and/or
  - b. Possessing educational qualification and experience as prescribed mentioned in the advertisement.
- 7. Prescribed education qualifications and experience are the minimum eligibilities required and mere fact that a candidate possesses the same shall not entitle him/her for being called for an interview. The Institute reserves the right to restrict the no. of candidates admitted for interview to a reasonable number, on the basis of qualifications and/or experience.
- 8. Selection of DPE (Civil) post will be through interview. However, Institute reserves the right conduct a written exam, if deemed necessary.
- 9. All Candidates should obtain NOC from the present employer and upload the same online. However, application without NOC shall also be considered, provided the candidate uploads a duly signed undertaking that the NOC will be submitted at the time of Interview.
- 10. Applications should be submitted well in advance, without waiting for the last date.
- 11. Call letters to attend the interview will be sent only to the short-listed candidates by mail. Candidates are required to check their registered e-mail ID frequently. No correspondence will be made with applicants who are not short-listed/not called for interview.
- 12. The Institute reserves the right to reject any application without assigning any reason. The Institute also reserves the right to cancel the advertisement/ recruitment at any stage without assigning any reasons. No correspondence will be entertained in this regard.
- 13. The institute reserves the right to conduct the interview online or in-person. Out station candidates called for interview will be paid railway fare in 2<sup>nd</sup>A/C from the place of duty/residence to Bengaluru and back by shortest route on production of original tickets.
- 14. Those who are joining the Institute service on or after 1st January 2004 are covered under the new pension scheme. However, employees who entered service before 31.12.2003 and who were governed by the CCS (Pension) Rules, 1972 shall be eligible for the GPF-cum-Pension-cum-Gratuity scheme subject to fulfillment of the conditions prescribed for this purpose by the Govt of India.

- 15. The Institute reserves the right to verify the antecedents or documents submitted by the candidate at any time during the service. In case it is found that the documents submitted by the candidate are not genuine, then his/her services shall be terminated, and disciplinary/criminal proceedings will be initiated.

Candidates who are awarded gradations under CGPA/GPA system in respect of Bachelor's/Master's Degree are advised to submit correct percentage of marks obtained as per the University/Institute guidelines for conversion of CGPA/GPA to appropriate percentage.
