Application Process & instructions to the candidates:

- 1) The candidate must be a citizen of India including Overseas Citizens of India residing outside India.
- 2) Interested eligible candidates should apply **through online**.
- 3) The Online application system on Bose Institute website <http://www.jcbose.ac.in> will accept the application from 17.12.2022 at 11.00 am (IST) till 16.01.2023 at 3.00 pm (IST).
- 4) Candidates are advised to fill up the online application carefully and provide the information as required. Candidates are requested to visit the Institute website (<http://www.jcbose.ac.in>) regularly for updates. No separate intimation will be sent to any candidate.
- 5) Candidates should carefully fill up all the details required in the online application form including age, educational qualification, details of valid community certificates, etc., as no correspondence regarding change of details will be entertained once the application is submitted. If any of their claims is found to be false or incorrect, it will lead to rejection of their candidature.
- 6) The qualification prescribed should have been obtained from recognized University/ Institutions.
- 7) Candidates should submit self-attested photo copies of required certificates and other documents, in support of their claims in the application such as age, reservation category (in the prescribed format), educational qualifications, experience, etc., along with the application.
- 8) The prescribed essential qualifications/ experience indicated are bare minimum and mere possession of the same will not entitle the candidate to be called for interview.
- 9) Experience gained/obtained after obtaining minimum qualifying degree will only be taken into consideration.
- 10) Candidates shall have to produce all the **original documents / certificates** in support of at their age, reservation category (in the prescribed format), educational qualifications, clearly mentioning the start date and end date of experience, etc., along with one set of a self-attested copies of the same, at the time of appearing for interview for verification, **failing which he/she will not be allowed to appear for interview**.
- 11) The Institute reserves the right to restrict the number of candidates call for written/ skill test / interview to a reasonable limit on the basis of qualifications, level of relevance of experience higher than the minimum prescribed in the advertisement and other academic achievements.
- 12) The Institute has the right to decide the mode of screening the applications for short listing and selection.
- 13) The Institute reserves the right not to fill posts advertised and to reject any or all applications without assigning reason.
- 14) **Candidates employed in Central/State Government or Semi-Government Organizations, Public Sector Undertaking, Autonomous bodies of Government of India or the State Government must apply through proper channel from their present employer. They may submit advance copies of their applications directly to "The Director, Bose Institute, Unified Academic Campus, EN 80, Sector V, Salt Lake, Kolkata - 700091 W.B. (India)" which will be considered provisionally. Candidates will be allowed to appear for the interview, only if the applications are duly forwarded (proper channel) by the employer along with Vigilance Clearance Certificate. The last date for receiving proper channel application in Bose Institute will be on or before 06.02.2023, failing which the application will not be considered. The Institute shall not be responsible for postal delays, if any.**

- 15) Candidates working in the contractual/tenural position in State/Central Govt Ministries/Departments/Universities/Autonomous Bodies/PSUs/NGOs drawing salary in pay scale or consolidated remuneration shall submit/attach NOC (in original) from their present employer/organisation with the application form, failing which the application will be considered as incomplete and will be rejected summarily.
- 16) Those candidates working in private sector organisation or foreign Universities or foreign Academic Institutions, shall submit the NOC (in original) with the application form, failing which the application will be considered as incomplete and will be rejected summarily.
- 17) Before sending the hard copy of application, candidates are advised to check whether s/he has attached all necessary documents, testimonials as per the advertisement or not. Bose Institute will not be held responsible for rejection of his/her application. No interim queries for short fall of any document in this regard will be entertained.
- 18) All supporting documents are required to be uploaded and therefore, candidates are advised to prepare the PDF files of the required documents before starting the online application process.
- 19) **On completion of filling/ uploading of the on-line application form and submission, Candidates should download a copy of the application form, sign, enclose the self-attested photo copies of the certificates / testimonials, etc., so as to reach by 16.01.2023 till 3.00 pm (IST) to “The Director, Bose Institute, Unified Academic Campus, Block-EN 80, Sector-V, Salt Lake, Kolkata 700091 by Speed Post/ Courier”. The last date of receipt of applications from candidates in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh (UT), Lahaul and Spiti District and Pangi Sub Division of Chamba District of Himachal Pradesh, Andaman and Nicobar Islands and Lakshadweep will be 31.01.2023. The institute shall not be responsible for postal delays, if any.**
- 20) (a) The retirement benefits will be regulated as per the New Pension System as applicable in Bose Institute.

- (b) Candidates in pensionable service in their present employment, will upon confirmation of service in Bose Institute, required to get their terminal benefits transferred to Bose Institute to avail the benefits of pensionable service under old scheme of Central govt. as per rule.
- 21) **Applications received through email / incomplete (i.e. without signature / affixing photograph)/not in the prescribed format without self-attested copies of relevant documents, testimonials/ not Through Proper Channel, without NOC, without Caste or PWD Certificate (for candidates claiming reservation) will not be considered and will be summarily rejected (Format for OBC Caste certificate is available on Bose Institute’s website along with detailed vacancy advertisement).**
- 22) **In addition to Sl. No. 20 above, the incomplete application in any form will not be entertained.**
- 23) No TA/DA shall be paid to the candidates attending the interview. Request for providing institute’s accommodation for attending interview will not be entertained.
- 24) Candidates shortlisted for interview will be informed through email as provided by the applicant in the application form.
- 25) All disputes shall come under the Kolkata jurisdiction.
- 26) Canvassing in any form or bringing in any influence of political or otherwise will be treated as a disqualification for the post(s). Interim enquiries will not be entertained. If it is found at any stage that any information given in the application is incorrect / false, the candidature / appointment is liable to be cancelled / terminated.
- 27) **Eligibility criteria including the upper age limit will be reckoned on the last date of submission of application i.e. on 16.01.2023 for all posts.**
- 28) **Age relaxation will be given to the eligible candidates as per Govt. of India guidelines.**
- 29) **Reservation rules as notified by DoPT, Govt. of India for reservation to SC/ST/OBC/PWD applicants from time to time will be applicable.**

- 30) The interview will be held in " **Bose Institute, Unified Academic Campus, Block- EN 80, Sector V, Salt Lake, Kolkata - 700091 W.B. (India)**"
- 31) The Institute may restrict the number of candidates to be called for interview on the basis of higher norms than the minimum prescribed qualification and experience.
- 32) The Institute shall verify the antecedents and documents submitted by a candidate at any time of appointment or during the tenure of service.
- 33) Candidates must be in sound health. They must, if selected be prepared to undergo such medical examination and satisfy such medical authority as the Institute may require.
- 34) Application submitted for a particular post is not transferable to any other post.
- 35) Information uploaded on the Institute website shall not be provided to the candidate under RTI Act, 2005. The uploaded information on the Institute website shall remain for a specific period only. Therefore, the candidates are advised to download the information and keep them for future reference. During the recruitment process, neither any application under RTI Act, 2005 shall be entertained nor shall information be provided. Factual information under RTI Act, 2005 shall be provided only after declaration of the final result and completion of entire recruitment process of this notification subject to conditions as per rule. Reply shall not be provided for any inferential or speculative question.
- 36) The character of a person for direct recruitment to the service must be such as to render him / her suitable in all respect for appointment to the service. Person dismissed by the Union Government or by a State Government or by a Local Authority or a Government Corporation owned or controlled by the Central Government or State Government any or Private Sector Organisation on any occasion will be deemed to be ineligible for appointment.
- 37) Selected candidate may be posted at any place within the jurisdiction of the Institute.
- 38) No interim correspondence will be entertained from any candidate at any stage during the recruitment process.
- 39) Mere fulfilment of the eligibility criteria is not enough for a candidate to be called for interview. The Competent Authority's decision will be final.
- 40) The number of vacancies can be increased or decreased as per the requirement of the Institute.**
- 41) The candidates are advised to visit the Institute's website regularly, as all updates regarding this advertisement including **Corrigendum, Amendment**, etc., if any, will be posted on the Institute's website only. No separate communication will be done to any of the candidate.
