## Advertisement for the post of Associate Engineer – I (SB D1 grade) on permanent rolls of Tata Steel Limited (Meramandali Unit)

Applications are invited from candidates interested to join Tata Steel Limited on permanent rolls. The location of posting would be Meramandali (Odisha).

<b>Minimum Educational Qualification</b>	Three (3) years full time diploma in Electrical / Electronics / Mechanical / Metallurgy / Chemical Engineering from any institute, recognized by AICTE Diploma holders in above discipline from R D Tata Technical Education Centre, Jamshedpur and J N Tata Technical Education Centre Gopalpur are also eligible to apply. Candidates with Part Time / Correspondence / Distance Learning will not be eligible.
<b>Mandatory Experience</b>	Minimum three (3) years of relevant work experience (excluding apprenticeship period), preferably in a Steel Plant as on 1 <sup>st</sup> April'23 after acquiring the Diploma qualification.
<b>Marks</b>	Minimum 55% marks aggregate in Diploma Engineering for General Candidates Minimum 50% marks aggregate in Diploma Engineering for SC/ ST Candidates
<b>Age</b>	General candidates should have been born on or after, 1 <sup>st</sup> April 1991 and before 1 <sup>st</sup> April 2005 SC/ ST candidates should have been born on or after, 1 <sup>st</sup> April 1988 and before 1 <sup>st</sup> April 2005
<b>Emoluments</b>	The selected candidates will be provisionally placed at starting Basic Salary of Rs.17,530/-pm with CTC of Rs 4.6 LPA, in the grade of SB D1. The other emoluments & benefits will be as per Company's rule applicable to this grade. Candidates possessing 4 years or more of relevant experience will be additionally compensated as per norms.
<b>Selection Procedure / Other Guidelines</b>	<ol style="list-style-type: none"><li>1. Eligible candidates will have to appear for Written Test and Interview process. Each stage will be an elimination stage.</li><li>2. Eligible candidates, who are currently employed with Tata Group Company / Subsidiaries/ Associate Company will need to furnish an NOC from the present employer before being considered for employment in Tata Steel. The NOC must be produced at the time of interview.</li><li>3. All selected candidates will have to be declared medically fit as per company's medical fitness standards, before their appointment.</li><li>4. All selected candidates will undergo Background Verification as per company's standard, before their appointment.</li><li>5. No reimbursement related to the travel will be made to the candidates in this process.</li><li>6. Candidates who are found ineligible as per the laid down criteria at any stage of selection process will be immediately disqualified from further selection process.</li><li>7. Canvassing in any form will automatically disqualify a candidate.</li></ol>
