#### I. COMPANY PROFILE

NTPC Limited was incorporated in 1975 under the companies act, 1956 with objective to develop and provide reliable power, related projects and services at competitive prices, integrating multiple energy sources with innovative and eco-friendly technologies and contribute to society.

NTPC became a listed company in 2004, with majority holding of 89.50% with the government of India which was further from time to time.

The Company has over the years, developed from a thermal power generator to an integrated power company with presence across entire energy value chain through backward and forward integration into areas such as coal mining power trading, distribution etc. On 19th May 2010, NTPC was granted the status of 'Maharatna' that resulted in enhanced autonomy in decision making.

Its registered and corporate offices are at New Delhi.

The company employed 16457 regular employees (Executives: 11112 and Non-excecutives: 5345) as on 31.03.2023.

The authorized and paid up capital of the Company was Rs. 16600 crores and Rs. 9696.7 crores respectively as on 31.03.2023.

Government of India's equity in NTPC, stands at 51.10% as on 31.03.2023, the rest being held by Institutional Investors, public & others.

#### II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Operations) is a member of the Board of Directors and reports to Chairman and Managing Director. He/She is responsible for ensuring proper operation and maintenance of Power stations for achieving high degree of reliability and efficiency of power generation and supply, keeping abreast of the technological development and adopting the same through renovation/modernization programmes to improve productivity and overcome various operational bottlenecks for sustained performance.

#### **III. ELIGIBILITY**

#### 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings :-

#### 3. QUALIFICATION:

The applicant should be an Engineering Graduate from a recognized University/ Institute with good academic record.

Applicants holding MBA/PGDM will have an added advantage.

### 4. EXPERIENCE:

The applicant should possess at least five years experience during the last ten years in construction/ technical operation/ maintenance of Power Plants in an organization of repute with establishments at multiple locations having pan India presence.

#### IV. DURATION OF APPOINTMENT
